301 Endless Yard Sale

Thank you for considering the Tobacco Farm Life Museum for your 301 Endless Yard Sale vendor space. The Museum is a private non-profit organization whose mission is to Preserve and Present the History and Heritage of the rural farming community. Public events such as this one assist us in raising funds to keep our doors open year-round.

The Endless Yard Sale is a 100-mile-long yard sale that is held annually along Highway 301 through Johnston County and through most of the State of North Carolina.

This year's event will take place on Friday, June 14th and Saturday, June 15th from 7am-5pm.

The Friends of the Museum will rent spaces on our grounds for individuals and organizations to sell family-friendly yard sale items. Spaces are 10'x10'. Some spaces are more tent friendly than others, but all spaces will fit a 10' x 10' tent. Spaces identified with a letter are \$50 per space per day and include a picnic table. Spaces identified with a number are \$45 a day and are in full sun.

We have included a map with the registration this year. If you would like to reserve a space, please indicate the table letter or space number you would like to reserve. Spaces will not be reserved until payment is received. Staff reserves the right to final decision on location but will try to place everyone in their requested spaces.

The Museum sees thousands of visitors for this event.

We accept Cash, Checks and Major Credit Cards. Spaces are limited so sign up early. The Museum has public restrooms and will be selling drinks and food on-site.

Event Rules and Regulations:

1. Vendors must bring their own chairs, tables and complete set-up.
2. Set-up is to be done no earlier than 6am and no later than 7am. Please note that vehicles must be moved from your site to the parking lot prior to 7am.
3. Clean-up/tear down must be completed by 6pm each day. There shall be no security provided. The Museum and its staff and/or Board of Directors will not be responsible for any items left on-site unattended.
4. Vendors/Demonstrators are responsible for picking up ALL unsold merchandise or demonstration materials. Should items be lost, stolen or damaged, the Tobacco Farm Life Museum is not responsible for compensating the vendor/demonstrator for the items.
5. Setup and cleanup will need to be done while staff is on the premises.
6. We cannot guarantee audience numbers.
7. Photos will be taken during the events for promotional and programming purposes. In signing the registration form, you give the Tobacco Farm Life Museum permission to take your photo/record your activities onsite.
8. Breakfast, lunch, and dinner will not be provided, but the Boy Scouts will be selling hot dogs, snacks, and drinks during the event.
9. Vendors shall not sell food or drinks to the general public.
10. Pets are prohibited in the buildings. If you plan to bring your pet, prior approval must be granted for them to be on the grounds. Additionally, they must be up to date on their shots and remain on leashes at all times.
11. Please feel free to bring assistants with you during the event; children 16 and under must be accompanied by an adult at all times.
12. The Staff will assign vendor locations in advance. Please check in with a staff member prior to setting up.
13. This location is not set up for overnight camping.

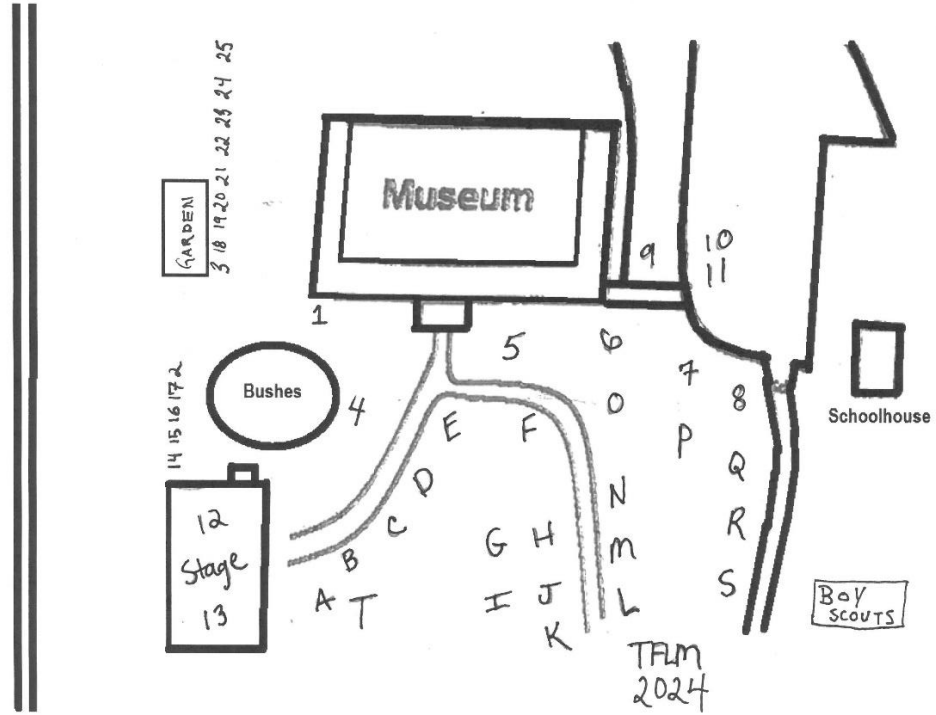
